The good news is that Calhoun County Schools will provide meals to children during the summer as part of the USDA Summer Food Service Program (SFSP). There are no income requirements and any child 18 years of age and younger may eat breakfast and lunch free. All meals must be eaten "on site;" leftovers may not be removed from the eating area. One meal may be served per child. The SFSP sites are listed below as well as the times for breakfast and lunch. Meals are served in the school's cafeteria. It's food that is in, while school is out.
