## MINUTES BOARD MEETING CALHOUN COUNTY BOARD OF EDUCATION FEBRUARY 21, 2019

The Calhoun County Board of Education met February 21, 2019 in the Administrative Building of the Calhoun County Board of Education 4400 McClellan Boulevard, Anniston, Alabama. Notice of this meeting was properly posted and provided to those who had requested direct notification.

The meeting was called to order by President Tobi Burt at 4:05 p.m.. The Pledge of Allegiance followed opening prayer by Mr. Donald Turner.

Board members present were: President Burt, Mr. Almaroad, Ms. Amerson, Ms. Hess, Ms. Hood, and Mr. Webb, establishing a quorum. Interim Superintendent Dr. Jon Paul Campbell was also present. Mr. Winn was absent.

Technology Coach Leann Bryan presented the January Technology Teacher of the Month certificate to Lauren Couch from White Plains High School. The Pleasant Valley High School Boys Cross Country Team was recognized for their 3-A State Championship.

During Board Member Comments, Mr. Webb shared about his visit to Saks Elementary Lunchroom and thanked the lunchroom staff for their hospitality. Mr. Webb thanked Dr. Campbell, Ms. Hood, Mr. Burt, and Ms. Amerson for their selection of the four candidates for the position of Superintendent. Ms. Hood and Ms. Hess questioned the "free" supply items being cut. Chief School Financial Officer Tina Parris explained the budget had been changed, but assured Board members that additional supplies would be provided as needed.

Interim Superintendent Campbell explained the process for the upcoming Superintendent interviews and shared the tentative schedule.

Chief School Financial Officer Tina Parris presented Monthly Budget Percent Analysis Comparison, Local Revenue Collections Analysis, *Helping Schools* Tag Sales and Financial Statements, and Bank Reconciliations for Board and public view. No action was required. The proposed FY2019 Budget Amendment #1 was presented for Board approval.

On a motion by Ms. Amerson and seconded by Ms. Hood, the Board approved an agreement with CMH Architects to repair the brick at the gymnasium entrance at Pleasant Valley High School as well as repair structure and install traffic coating at the patio connector between buildings, and install security doors (see attachment).
